2. Owing to the overwhelming response each year, a session of no more than 45 minutes will be allocated to each successful application according to the priority indicated above.
3. The first application of each company will be allocated timeslot on the first-come-first-served basis. Incomplete applications will not be handled and given any timeslots. Any available timeslots after the first assignment will be allocated to the second application (if applicable) on the same basis. Should there be further timeslots available, the subsequent assignment(s) will follow the same mechanism.
4. If any companies would like to change their timeslot(s) after the announcement of the timeslot(s), Organiser will rearrange only after all successful applications confirm the acceptance of their timeslots.
5. On the event day, the performers should arrive at the Children's Paradise Performance Stage 15 mins prior to the presentation start time. If the presentation does not match with the submitted information, Organiser reserves the right to terminate the Children's Paradise performance(s) of that company.
6. The applicants should be responsible for the admission arrangement of any invited guests, e.g. on-stage performers, awardees of presentations, guest audiences etc. For ticketing details, please refer to the Book Fair Official Website.
7. For any music, audio and visual to be played in the fairground, companies are required to apply for the copyright license prior to the Book Fair 2019. Organiser will not be responsible for any copyright infringement.
8. Organiser reserves the final rights on any application result, timeslot allocation and may make alternations to the performance schedule without prior notice when needed.
